Your Guide to City of Rio Vista Commissions

WHY SERVE ON A COMMISSION?

Serving on a commission is a way to put your love, concern, and hope for your community in action. You get to have your voice be heard, work with others who share your passion, and see the fruits of everyone's hard work become a reality. Another added perk in volunteering to serve in a commission: applicants / candidates who do community service and are civically engaged are viewed favorably by colleges, universities, scholarship programs, and potential employers — a great resume builder!

CAN I APPLY TO SERVE ON A COMMISSION?

Commission vacancies are posted on the bulletin board outside City Hall, the City website, and via newspaper (The Beacon). There are opportunities to serve for both youth and adults. For youth, you must be a resident and a student in the City of Rio Vista. As to adults, you must reside in Rio Vista and meet the criteria set forth by the commission (if any special requirements are outlined per the Rio Vista Municipal Code).

HOW LONG ARE THE COMMISSION TERM LIMITS?

Youth commissioners have one (1) year term limits with a possibility for reappointment. Adult commissioners have four (4) year term limits with a limitation of two (2) consecutive terms. Adult commissioners are appointed by the Mayor. Youth commissioners are appointed by the respective Commissions.

HOW MANY CITY COMMISSION ARE THERE, AND WHAT DOES EACH ONE DO?

There are currently four (4) City commissions. Listed below are the commissions and what each one does:

AIRPORT ADVISORY COMMISSION – MEETS QUARTERLY ON 3RD MONDAY OF THE LAST MONTH IN EACH QUARTER (MARCH, JUNE, SEPTEMBER, AND DECEMBER) AT 6 PM

Want to learn more about aviation and why Rio Vista Municipal Airport is such an important asset to the City and economy? If so, then there is a commission seat waiting for you! The Commission studies and analyzes matters relating to fees, rental schedules, and standards of service of the municipal airport, and proposes changes in economic development and land use policies which affect the airport. One student member seat is currently being added as of September 2023 pending City Council approval.

PARK & RECREATION COMMISSION - MEETS QUARTERLY 4TH MONDAY OF THE LAST MONTH IN EACH QUARTER (MARCH, JUNE, SEPTEMBER, AND DECEMBER) AT 6 PM

Are you passionate about sports, art, or music? If so, then this commission is for you! By sitting on this commission, you will have a voice on what types of recreational opportunities and facilities are offered in Rio Vista. The Commission advocates and promotes programs and services designed to meet residents' needs, and makes recommendations to the City Council on matters pertaining to public recreation. One student member seat is currently being added as of September 2023 pending City Council approval.

PLANNING COMMISSION - MEETS 2ND WEDNESDAY OF EACH MONTH AT 6 PM

Want to know more on how the City plans to grow in the next 20 years? If so, then roll up your sleeves and join this commission! The Commission recommends plans for the regulation of future growth, development, and design of the City as well as carries out the provisions of the zoning ordinance. One student member seat is currently being added as of September 2023 pending City Council approval.

PUBLIC SAFETY OVERSIGHT COMMISSION – MEETS 4^{TH} MONDAY OF THE LAST MONTH IN EACH QUARTER (MARCH, JUNE, SEPTEMBER, AND DECEMBER) AT 4 PM

Are you passionate about our City's safety, peace, and quality of life? If so, then join this commission and learn more through the perspectives of Police and Fire. The Commission reviews/analyzes public safety issues including crime and fire prevention, fire protection, traffic safety, emergency preparedness, emergency medical services, homeland security, and code enforcement.
