As your City Manager, it is my honor to be part of the team that serves the residents of Rio Vista and to work alongside the Mayor, City Council, and our dedicated City employees to enhance the quality of life for all who live in, work or visit Rio Vista— "The Gateway to the Delta."

This past year, our City continued to move forward, and we expect 2020 will again bring great things to Rio Vista. This Annual Report provides a brief summary of many—but not all—of our accomplishments in 2019. Our 2019 Annual Report highlights many of our achievements from this past year, including:

- Online utilities portal: 1,653 (31%) people have signed up.
- For the second year in a row, the Annual Audit was flawless—no writeups or management comments. We have now received serval awards for our budget format and presentation.
- The City continues to improve streets, sidewalks and pedestrian crossings.
- Trilogy is now built out. There are 3,008 homes in that subdivision.
- LGI Homes began selling homes in June of 2018 and has pulled 220 permits.
 The family home section is built out. In addition, they have pulled 60 permits for homes in the active adult phase.
- Job Creation: Rio Vista Farms now has approximately 98 employees. There are several more businesses at the Business Park that are under construction, and when completed, should add additional jobs.
- Additional Tax Revenue/fees from Rio Vista Farms totaled \$218.786.
- We purchased and received a new state-of-the-art fire engine and brush truck.
- Improved Bruning Park by adding new restrooms and a basketball court.
- On the verge of completing \$6.3 million in infrastructure improvements to the Business Park.
- Continue to improve our abilities to use social media for increased public communication.
- Implemented a battery and lightbulb drop off program to assist the citizens with disposing of these Household Hazardous Waste items.

 Completed Phase I of the Energy Efficiency Projects saving City funds and the environment which included upgrading lighting to LED, HVAC Replacement and Improvements, Installation of Solar on City Hall and the Fire Station.

- Implemented new Monthly Update Reports to Council outlining the accomplishments of each department on a monthly basis. This not only keeps the Council and Citizens apprised of complete items it also allows staff to share highlights of their hard work, dedication and daily contributions to the City.
- We continued to embrace the values and traditions that make Rio Vista a
 desirable community to live while also adopting new technologies to run our
 municipal organization as efficiently as possible.

Due to staffing issues within the police department, the City contracted with Solano County Sheriff's Department for law enforcement series. Specifically, 12 deputies will be dedicated to the city for our law enforcement needs, replacing the 16 sworn positions the City had in the department. This talented and experienced team is being led by Lt. Jackson Harris who is our Police Chief under the contract. Everyone is working to make this transition as smooth as possible.

Looking forward, 2020 is expected to be another successful year for the City, but there will be challenges. While home sales are expected to continue, we are seeing a slowdown in sales. The city continues to suffer from revenue "leakage" caused by people shopping outside the city—whenever possible, shop local and support our businesses.

Looking back, I can see how much the city has moved forward these past several years. But we need to continue moving forward. There is no shortage of challenges in the city. Today was tough, tomorrow will be harder. But I do believe we need to continue our forward progress and that our challenges can be managed by our leadership team. The Mayor and City Council lead by providing policy and a vision for our government. Staff implements those decisions while thoughtfully and efficiently delivering services and capital projects to support the Council's vision.

We are blessed with many community members who willingly serve on commissions and boards that engage on a range of issues. They invest in our future by dedicating their time and passion for the city. We are all working to grow the City of Rio Vista into the best place in Solano County to live, work, and play. Together, we will continue to champion Rio Vista's proud traditions while building a stronger community.

We remain strongly committed to ensuring Rio Vista is efficiently run and that we continue providing excellent customer service and a quality of life that makes Rio Vista a premier place to live as well as a destination for future business, technology, culture and tourism. In short, we will continue to innovate and improve our processes and services to maximize our efficiencies and take advantage of opportunities, presented or created, to benefit the City and its citizens. We look forward to a great 2020!

MESSAGE FROM THE FIRE CHIEF

Community Members,

It is my pleasure to share with you the 2019 Annual Report for the Rio Vista Fire Department ("RVFD"). This report will include an overview of our 'calls-for-service', our accomplishments for 2019, as well as our goals for the next year.

We continue to serve the Community 24/7/365, staffed with full-time professional Firefighter/Paramedics, responding to all-risk emergency and non-emergency callsfor-service. Our staffing is augmented by intern Firefighters and volunteers. For significant incidents and coverage, our Department is supported through Mutual Aid agreements we have with other Fire Departments in Solano, Sacramento, San Joaquin and Contra Costa Counties. We continue to participate in Master Mutual Aid Reponses throughout the State (strike teams). The cost-recovery from those incidents is directed toward funding new apparatus.



While 2019 was a relatively mild year for major incidents in the State, it remained a challenging year in Solano County and Rio Vista. Our Mutual Aid agreements continued to prove invaluable as the County Fire Departments came together to mitigate multiple incidents, some of them in our own "backyard".

Last year, the RVFD also increased its staffing. Two new Intern-Firefighters and a volunteer Fire Inspector were added to the roster; and, in July, we hired a full-time Fire Battalion Chief. The Battalion Chief will assist the Fire Chief in the leadership and management of the Fire Department. Specifically, this position will oversee Operations and Training. The Fire Chief and the Fire Battalion Chief will rotate "duty officer" coverage to provide for a 24/7 "Command Officer" as per the recommendations of NFPA 1710.

We continue to serve for ways to be responsive to the needs of our community and be innovative in our service to the residents of Rio Vista and the Delta Fire District. 2020 will be a challenging year, as we anticipated an increase in calls for service and as we begin to discuss the future of Measure O. We are grateful for the opportunity to serve as your Fire Department. We look forward to the future and working on solutions together as a Community.







2019 Year in Review

Your Police - Our Community

Overall 2019 will be remembered as a year of building for the Police Department. At the end of the summer, several key positions were vacated leaving a void in police administrative services. The City Manager quickly reacted by reaching out the Sheriff's Office to assist with helping to fill this void. Solano County Sheriff's Office Field Operations Captain Rustin Banks was allowed to come to Rio Vista to provide the needed administrative assistance.

Due to a growing number of department vacancies and a need for immediate training, the Sheriff's Office was approached about a contract to provide law enforcement services for the city of Rio Vista. While the finer points of the contract are still be authored as of the time this is being written, the contract will allow for seven Deputy Sheriff's, two Sergeants, a K-9 Officer for Rio, a School Resource Officer and a Lieutenant to act as the Chief of Police.

Rio Vista Police Department continues to be a shining example of community-oriented policing. Outreach through social clubs, schools and social media, for example, have helped identify what is most important to this community. Going forward, 2020 will be a fantastic year for public safety and involvement between the community and the Rio Vista Police Department.

The City of Rio Vista Public Works Department is dedicated to providing effective and efficient services and maintaining the Cities infrastructure to ensure the safety, health and enjoyment of the community. The Department provides support for all City departments, local, regional, state and federal agencies by working with our community in all of our efforts to sustain and improve the quality of live and deliver the best services possible. Rio Vista Public Works Department provides the following services:


- Water: Operates and maintains over 42 miles of infrastructure, six water wells, one water treatment facility, two 2-million-gallon storage facilities, and operates and maintains the city's water distribution control system (SCADA). Meter reading.
- **Sewer:** Maintains over 40 miles of infrastructure pipelines and manholes and two wastewater treatment plants.
- Storm Drain: Operates and maintains the drainage system, leave collection and flood control.
- Parks: Operates and maintains all city parks and the city swimming pool.
- Transit
- Solid Waste and Recycling
- ATOD (Alcohol, Tobacco and Other Drugs) Alliance





As of December 31, 2019, 1,606 utility accounts have been signed up for Online services, approximately 31% of the total connections.




FISCAL YEAR 2019-20 ADOPTED BUDGET

REVENUES BY SOURCE (\$62,728,781)




FISCAL YEAR 2019-20 ADOPTED BUDGET

GENERAL FUND MEANS OF FINANCING (\$7,002,639)




FISCAL YEAR 2019-20 ADOPTED BUDGET
