- Continue to evaluate the options for the second fire station (Airport Road), working closely with a Project Manager to make recommendations on construction.
- Researching and securing additional grant opportunities.
- Continue community outreach through social media and community events.
- Establish a 'school program' whereby staff will be integrated into local schools for the purposes of education and increasing safety.
- Identify needs and a replacement for 'Truck 55'.


FUTURE LONG-TERM GOALS (3-5 YEARS)



OPERATIONS:

The largest Division within the Rio Vista Fire Department is its Operations Division. The Operations Division is responsible for emergency medical services, fire suppression, mitigation of disasters, and rescue activities.

Operations Division members provide a wide range of services to the Rio Vista community. They are responsible for responding to emergencies and calls for service that threaten life and property in the City of Rio Vista, the Delta Fire District, and our mutual aid areas. The Rio Vista Fire Department also provides non-emergency services to manv the community including smoke detector battery changes and public education events, including tours of the fire station and apparatus, and fire and life safety presentations.



The Operations Division is comprised of three shifts which staff two engine companies. Personnel are assigned to Station 55 and they respond to over 2,500 alarms per year. Approximately 64% of all emergency calls are for medical and services provided to reduce risk to our community. Rio Vista Fire Department provides Advanced Life Support (ALS) level of care and approximately 65% of our personnel are trained to the Paramedic level.



TRAINING:

The Rio Vista Fire Department Training Division exists to serve the training needs of fire service personnel. We provide training, education, and certifications to members who are vital to the organization's success. We promote excellence by employing state-of-the-art equipment, training, and a continued commitment to the health and safety of fire department members. We strive to provide the knowledge and skills necessary to maintain the safest work environment possible for members as well as protection and service for the citizens of Rio Vista and surrounding communities. The Training Division also seeks to meet or exceed State and National training standards for 'all-risk' emergency operations, and we document our performance for regulatory organizations such as OSHA and ISO (Insurance Services Office). The training in the Rio Vista Fire Department



begins with the minimum standards that are a requirement for all members. At a minimum, all members are required to have completed a State Fire Marshal accredited fire academy or be certified as a Firefighter I, maintain the requirements of a wildland firefighter ("red card"), and must be certified as an EMT (paramedic preferred). The department's annual training plan builds on this foundation of knowledge and requires all members to meet or exceed 192-hours of 'inhouse' training per year.

EMERGENCY MANAGEMENT:

The Rio Vista Fire Department is the lead City Department for 'all-risk' emergency management in the City and the Delta Fire District. Preparedness, Response, Recovery, Prevention and Mitigation are the interrelated concepts

adopted by the City's Emergency Operations Plan. Rio Vista Station 55 also hosts the City's Emergency Operations Center (EOC). This facility has been outfitted with technology and resources that enable City staff to address the emergency needs of the City, while working closely with our partners at Solano County. The Fire Chief is designated as the EOC Director and works under the general direction of the Emergency Services Director/City Manager.

Prevention Mitigation Recovery Response

FIRE PREVENTION:

The Fire Prevention Division is led by the Fire Chief (Fire Marshal) whose responsibilities include annual fire inspections, new construction plans review, weed abatement, and fire investigation.

In the past, the Fire Prevention division was staffed with two (2) parttime/volunteer fire inspectors, however, both of those individuals have retired. As part of our 2023 plan, we will be revaluating those positions



and determining the needs in Fire prevention.

The biggest component of Fire Prevention is annual Fire and Life Safety inspections. During an annual fire and life safety inspection a fire prevention inspector will determine if a location has violations. Typically, these violations come in two varieties: violations of general fire safe practices or the lack of maintenance of (or absence of) required prescriptive building features. If violations are identified and can be immediately corrected or if the violations are minor in nature the Fire Prevention Inspector will issue a written order to address the violations. The Fire Prevention Inspector may alternately send a letter with the violations noted with an order to comply. Re-inspections are performed for fire and life safety hazards. These "distinct hazards" will be re-inspected, typically after 14-30 days depending on the severity and if each

violation has been corrected there will be no re-inspection fee. The only fee would be for the initial inspection previously completed. However, if the noted violations have not been corrected during the first re-inspection, additional inspections will need to be performed until all corrections have been made, up to and including administrative citations and/or costs for additional litigation.



FIRE INSPECTOR, DAVE REDDELL – RETIREMENT:

Dave Reddell first retired from a career in the fire service in the mid 2000's, as a Truck Captain and Hazardous Materials specialist with a Fire District in Northern California. After spending a few years traveling with his wife, he moved to Rio Vista, and joined RVFD as a "Hot Shot".

Within a short time, Fire Chief Hartford recognized his experience and asked him to assist with Fire Prevention. Dave has spent the last several years serving our community as a volunteer Battalion Chief and Fire Inspector, leading the efforts of the Fire Prevention Division.

In December of 2022, Dave decided he wanted to spend more time with his family, traveling around the U.S. and announced his "(re)Retirement".

We will miss Dave and want to thank him for his contributions to our City and Fire Department.

RVFD "HOT SHOTS":

The Fire Department has a community support group called the "Hot Shots", whose primary function is to support the Fire Department in public events and to assist in improving the service provided by the Department by fundraising. The Hot Shots was formed by a group of community volunteers in 2015 and is a non-profit 501c3 organization. Currently, we have 14 active Hot Shot members. In 2022, the Hot Shots raised over \$50,000 in support of RVFD.

This past year they participated in several community events including fund raising activities such as Rio Rock Concert event, supporting the Lion's Club Bass Derby Pancake breakfast, Airport Days and more. The Hot Shots held their own, very successful, event at the Legion Hall.

In collaboration with the Rio Vista Professional Firefighter's Association, we also assist in other special events including the annual "fire truck rides".

The Mission of the "Hot Shots" is to continue to support the Rio Vista Fire Department by assisting with staffing at public events, and by fundraising to assist with improving the level of service we provide.



OFFICE OF EMERGENCY SERVICES (OES) FIRE ENGINE ASSIGNMENT:

In August 2022, the Rio vista Fire Department was "assigned" an "OES Engine" by the State of California, Office of Emergency Services, Fire and Rescue Branch. This Fire Engine is fully funded by the State of California and assigned to Rio Vista for use in our Community and for response throughout the State under Mutual Aid ("strike teams").

Taking advantage of increased staffing levels of four per day, the Fire Chief applied for this program (with the approval of City Council) and was successful in the application. While the Fire Engine can be used locally and helps the Fire Department when one of our engines is out-of-service, its primary mission is to respond on "Strike Teams".

We thank the City Council for authorizing our participation in the program and thank CAL OES for entrusting us with this Engine.

Contract Status

We are in the second year of a two-year contract. Staffing levels remain the same as the original contract. The Department command staff consists of a Sheriff Lieutenant assigned as Police Chief and two Sergeants as watch commanders. Eight deputies serve on patrol as Police Officers, and a ninth deputy sheriff splits his time filling roles as a School Resource Officer (SRO) and Problem-Oriented Policing (POP) Officer.

Police K9 Rio has retired, and a new police K9 is being sought for purchase by the Sheriff's K9 Trainer. We continue to operate with one full-time Public Safety Support Manager, one full-time Community Service Officer (CSO) who also serves as an Evidence Technician, and a part-time CSO working as a Code Enforcement Officer. This is in addition to our volunteers who assist with office and clerical duties, general upkeep, and fleet maintenance.

Some Cosmetic Changes

We also opted to redesign our patrol cars to reflect the community we serve rather than the generic badge emblem on the vehicles. Staff selected two designs with community input via social media. A "bridge car" design with two white doors and a representation of the Rio Vista bridge spanning both and an all-black "slick top" (inside-the-window emergency lights replace the visible light bar on top) for traffic enforcement.



To increase volunteers' professionalism, we have started outfitting them with uniforms for outside non-clerical functions.

Rio Vista officers are often questioned about their Sheriff badges and Rio Vista Police patches. To bring the two together, we developed badges to integrate both.



Traffic Safety

This year was particularly challenging when it came to traffic. Crashes on the State Routes 12 and 84 resulted in six deaths and numerous injuries.

Also, for the second consecutive year since California's Criminal Justice Realignment reduced incarceration times, felony suspects rammed our officers while trying to escape capture.


2022 ACCOMPLISHMENTS

This year, with great pride, the Rio Vista PD has restarted two valuable but defunct programs and created a new one.

DUI Expert Recognized

Officer Snedeker was at it again this year. With 47 DUI arrests, he beat his record of 37 from last year. This feat earned him recognition as a top DUI enforcer for the Sacramento Region (based on an arrest-per-capita formula).

Officer Snedeker also completed training as a Standardized Field Sobriety Test (SFST) Instructor. He now represents Rio Vista PD as he teaches classes for other local law enforcement agencies through the Fairfield Police Training Facility courses.



Public Safety Citizens' Academy

Partnering with the Rio Vista Fire Department, the Police Department co-hosted the first Rio Vista Public Safety Citizens' Academy. Participant students from the community learned about the history of both Police and Fire services. On the police side of the curriculum, they also learned about fundamental Criminal Law, traffic enforcement, Criminal Investigations (detectives), SWAT, crisis negotiations, Corrections, De-escalation, and the use of force. At the end of the seven weeks of evening classes, they got to put their training to work in an immersive police video training simulator.



2022 Public Safety Citizens' Academy

Police Cadets

Rio Vista Police cadets participated with the Cities of Vacaville, Fairfield, Antioch, and the Solano Sheriff's Office, bringing together 26 cadets to a four-day live-in intensive training program starting. They started each morning at 6 AM with physical training and trained until 9 PM each night. Only 22 cadets graduated from the program, including *both* RVPD cadets.

PUBLIC WORKS DEPARTMENT



The City of Rio Vista Public Works Department provides excellent services to the community. The department maintains infrastructure to ensure the safety, health, and enjoyment of the community. The department provides support to all City departments, local, regional, state, and federal agencies by working with our community. We strive to sustain and improve the quality of life and deliver the best services in the most cost effective and efficient manner possible.

We provide the following services:

- Water: Operate and maintain over 42 miles of infrastructure, six water wells, one water treatment facility, and two 2-million-gallon storage facilities; operate and maintain the City's water distribution control system (SCADA); collect meter reads.
- Wastewater: Maintain over 40 miles of infrastructure pipelines and manholes and two wastewater treatment plants.
- **Storm Drain**: Operate and maintain the drainage system, leaf collection and flood control.
- Parks: Operate and maintain all city parks and the city swimming pool.
- Transit
- Solid Waste and Recycling including the Household Hazardous Waste Events.
- **City Facilities:** Responsible for all city buildings and properties as follows:
 - ✓ City Hall
 - ✓ Senior Center
 - ✓ Youth Center
 - ✓ Police Station
 - ✓ Fire Station
 - ✓ Army Base

- ✓ Library
- ✓ Airport Terminal Building
- ✓ Corporation Yard
- Airport Staff is responsible for operations and maintenance.
- Landfill Staff preforms inspections and is responsible for preventive maintenance.
- Streets and Sidewalks Staff is responsible for the operations and maintenance including coordination with the County and Caltrans.
- Engineering and Administration Staff coordinates engineering and plan review for the city's infrastructure.
- On-Call Services The Public Works Department is available 24/7 for water related emergencies. For after hour water emergencies please call 707-249-7510. Water emergencies include main breaks, service line breaks or damage, fire hydrant repairs, brown water, vandalism, and other urgent items that require emergency service.
- Current Staffing 15 full-time employees.





ANNUAL COMPREHENSIVE FINANCIAL REPORT FISCAL YEAR ENDED JUNE 30, 2022




FISCAL YEAR 2022-23 ADOPTED BUDGET





FISCAL YEAR 2022-23 ADOPTED BUDGET
