### Point-In-Time Homeless Count

Ten (10) homeless persons were documented during the Point-in-Time (PIT) Count. The PIT Count is a count of sheltered and unsheltered people experiencing homelessness on a single night. The US Department of Housing and Urban Development requires an annual count of people experiencing

homelessness in order to qualify for funding. This number does not include “couch surfers” or those living in recreation vehicles connected to utilities.
