At their regular meeting of May 7, 2024, the City Council will consider the following:

- A Proclamation in Support of Asian Pacific American Month
- Consolidation of the General Municipal Election for City Officials, and Establishing Policies for Candidate Statements
- Approval of the Road Repair and Accountability Act of 2017 (SB1) Project Lists for Fiscal Year 2024-2025
- Authorization of the Filing of a Notice of Completion (NOC) and Subsequent Acceptance of the Highway Safety Improvement Program (HSIP) Cycle 10 Grant-Funded Pedestrian Crossing Project
- Approval of Updated Documents for the Rio Vista Airport related to the Rules and Regulations, Key Fob, and Parking Placard Application
- Approval of the Purchase and Installation of Filter Media for the Well 10 Arsenic Treatment Facility
- Authorize the Award of a Consultant Services Agreement to Air Exchange of Fairfield for the Procurement and Installation of a Source Capture Vehicle Exhaust Removal System
- Awarding the 2023-2024 Rio Vista Student Scholarship in the amount of \$1,000

- Placement of a Transient Occupancy Tax (TOT) Measure on the November 2024 General Election
- Awarding Matching Grant Funds to Sam’s Custom Cakes & Catering and Rio Vista Bakery as part of the Economic Development Grant Fund Program

### **Mellin Levee Workshop**

Staff attended the Mellin Levee Workshop to discuss the Cache Slough Mitigation Bank and Little Egbert Multi-Benefit projects and possible paths for work on the Mellin Levee and Hwy 84. Staff scheduled a follow up meeting with the Solano County Water Agency to further discuss the proposals.

### **General Plan Working Group**

As of April 18, 2024, the General Plan Working Group concluded their regular scheduled meetings. Next steps for the General Plan include:

- A public review draft document will be prepared and is anticipated to be complete by mid-late May for public review.
- Two community workshops will be held on June 6, 2024, one from 2:00 to 4:30 p.m and the other from 6:00 to 8:30 p.m. Both meetings will be held at the Veterans Memorial Building, located at 610 Saint Francis Way.
- Special meetings may be held to review the final draft.
