October 17, 2023, City Council Meeting

Actions taken by City Council at their meeting on October 17 included:

- Adopted an ordinance amending chapter 17.80 (Outdoor Dining) of the Rio Vista Municipal Code.
- Approved amendments to the memorandums of agreement with Solano County Sheriff's Office for fire and police dispatch services;
- Awarded a construction contract for a grant funded Pedestrian Crossings Project.

City Council also received a presentation from Dan Stokes regarding "branding" and directed staff to prepare an RFQ for branding consulting services to be considered at a future Council meeting.

Pedestrian Safety and Traffic

Rio Vista Downtown Business Association

City staff also provided information in regards to the Economic Development Fund matching grant program and the Community Development Block Grant COVID-19 Business Assistance Program.

Solar App+

City staff and Solar App+ are testing the City's new app for solar permit applications and anticipate launching for public use by the end of the month.

Municipal Rates & Utilities Committee (MRUC)

The MRUC met on October 19, whereby wastewater system capital improvement projects and rates were discussed.
