October 3, 2023, City Council Meeting

The City Council will consider the following at their October 3, 2023 City Council meeting:

- Second reading of an ordinance regarding off-street parking and loading standards;
- Purchase of a valve maintenance trailer and three Ford trucks;
- A second amendment to the Agreement with Transportation Concepts to operate and maintain the Delta Breeze;
- Introduction of an ordinance that will update Chapter 17.80 of the Rio Vista Municipal Code in regard to Outdoor Dining;
- Discussion of the vision of the City Recreation Program and Facilities;
- Approval of guidelines for the Citywide Business Matching Grant Program;
- Approval of a land exchange agreement with John Grima exchanging City-owned property in the business park for five acres of land on Harris Road;
- Discussion of the revised Department of Water Resources and United States Fish and Wildlife Service Army Base Project;
- An amendment with R3 Consulting Group to extend the term and budget for hauling agreement negotiations;
- A conflict consent and waiver allowing the law firm representing the City of Rio Vista, Kronick, Moskowitz, Tiedemann and Girard ("KMTG") under certain described conditions to also represent California Forever LLC;
- Discussion of a planning study for 62.5 gross acres located at Church and Airport Roads.

CAP Solano Homeless Services Staffing

At the CAP Solano Staffing meeting City Managers were not able to come to a funding agreement, as some jurisdictions did not want to contribute at all, some felt they were contributing to homeless issues or to CAP Solano in other ways, and others felt it was hard to commit to a contribution level without understanding the services they will receive. Another meeting is being scheduled to discuss further.

I attended a Senior Center meeting on September 27th. Volunteers are working to hold additional activities for seniors.

2x2 Meeting

At the 2x2 (City/RDUSD) meeting, the Committee recommended the District and City Council approve the Joint Facility Use Agreement. Other items discussed include a potential land exchange agreement for a municipal well, Brann Ranch development progress, youth commissioners on City Commissions, \$1,000 Scholarship Program, development of a City Recreation program and availability of facilities, and pedestrian safety around schools.
