A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIO VISTA APPROVING THE FIRST (1ST) AMENDMENT TO THE CITY OF RIO VISTA'S ECONOMIC DEVELOPMENT STRATEGIC PLAN (EDSP)

WHEREAS, since 2021, the City Council has identified economic development as a key priority of the City and directed staff to report back on different approaches for accomplishing economic development goals; and

WHEREAS, during the March 15, 2022 regular meeting of the City Council, the City Council adopted Resolution No. 2022-028 approving a \$55,000 consulting agreement with Stone Creek Partners to formulate an economic development strategy document for the City; and

WHEREAS, from June 2022 to August 2023, Stone Creek Partners (a consulting firm) and staff engaged various community and key stakeholder groups regarding economic development; and

WHEREAS, City staff presented the first draft of the Economic Development Strategic Plan (EDSP) on December 19, 2023. With the City Council and the public providing feedback regarding the draft document, City Council directed staff to revise the draft EDSP document and report back at a later meeting date; and

WHEREAS, City staff presented the second draft of the EDSP on February 20, 2024. With the City Council and the public providing feedback regarding the second draft document, City Council directed staff to revise the second draft EDSP document and report back at a later meeting date; and

WHEREAS, City staff presented the third draft of the EDSP, for City Council to discuss, consider, provide feedback, and eventually approve the EDSP during the City Council's March 5, 2024 regular meeting; and

WHEREAS, during the March 7, 2024 meeting of the General Plan Working Group (GPWG and/or the "Committee"), a member of the Committee provided recommended changes to the EDSP; and

WHEREAS, City staff is now reporting back to City Council regarding these proposed changes from the March 7, 2024 GPWG Meeting to discuss, consider, provide feedback, and eventually approve said changes for incorporation within the EDSP.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF RIO VISTA AS FOLLOWS:

A. The City Council has discussed, considered, and provided feedback regarding the recommended changes as proposed by the GPWG.

- B. The City Council hereby approves said recommended changes and directs staff to incorporate said changes to the recently adopted City of Rio Vista's EDSP
- C. The City Council hereby memorializes the incorporation of changes as recommended by the GPWG as Amendment One (Amendment 1) of the EDSP, with an "as amended" date of March 19, 2024.
