4.1 WELL 11, 13 AND 16 UPDATES

Well 11 – work is complete and is working.

Well 13 – having power fluctuations and motor problems. PG&E has tested the well on-site. The city has spent \$30,000 so far on this well.

Well 16 – There were some issues when the State came out to test and will test again the week of June 20th. The State must approve the well before the water goes into the distribution system. Shea is still the owner of the well until the project is completed and the Council votes to accept the project as complete.

4.2 WASTEWATER CONSOLIDATION PIPELINE AND PLANT UPGRADES

The RFP has been sent to the City Manager for the consultants for the rate study. The pipeline is almost completely planned out. The pathway will be mostly on city rights-of-way. The EIR has not been done yet. The membership has asked that HydroScience possibly attend the next meeting.
